Good morning Chief Superintendent Matt Peggs,

We spoke last summer prior to my fleeing from Ontario in August 2022. I asked what would be required for the RCMP to launch an investigation into a massive, Ottawa-based crime ring that is

linked to international human trafficking ... & **implicates** Ottawa's law enforcement, its Crown Attorney's Office and a large part of Ontario's legal and judicial communities.

Still involved in a multi-level, legal quagmire that requires ongoing attention, I've done my best to re-organize this evidence for easier comprehension (see summary below). However, uploading **all** of the evidence will take thousands of hours; at least, it did the first time.

I hope to speak to you soon in order to answer any questions you might have; or, receive advice on how to advance matters from Newfoundland be it:

- a. under the jurisdiction of NL RCMP cc'd above (I'd have to move to their jurisdiction which is totally doable); or,
- b. with the Royal Newfoundland Constabulary which covers Paradise, where I currently reside (also cc'd).
