Hello counsel,

Further to our settlement discussions at court last month, I am writing to propose several different means of resolving the CYFSA matter;

1. The Society would be agreeable to participating in mediation to come to a final agreement regarding access (if Ms. Moore will consent to a s. 102 custody order to Mr. Kiska). As stated at court, since neither parent is legally aided, (to my knowledge) and therefore ineligible for LAO mediation, and there is no further Ministry funding for mediation until April 2020, the parents would need to pay for mediation out of pocket.
2. The Society would also be agreeable to resolving this matter with a final custody order to Mr. Kiska, with an agreement for the balance of the Application (access regime) to be determined in Family Court.
3. The Society is also generally agreeable to whatever access regime the parents can agree on between themselves, if there are possible offers to settle, the Society would welcome these being exchanged at the parties' earliest convenience so as to move the matter forward in an expeditious manner.

Thank you for your consideration. Once we receive the ordered disclosure of records, we will consider whether we are proceeding to a SJM on the Society's SRA.
