Thank you for your letter. My apologies, as I am unfortunately unable to answer the vast majority of the questions you requested, as they are outside my scope, and extend beyond the short time in which I was involved in your care.

I was briefly involved in your care during an initial psychiatric hospitalization from March 3-5, 2013. At that time, the diagnostic impression was felt to be in keeping with Bipolar disorder (manic features) and marital discord (relational tensions with spouse). Collateral information was obtained from your parents, and from your spouse at the time. For further details, the discharge summary is available through TOH Health Records, alongside subsequent assessments by other clinician colleagues in the years following.

In general, the diagnostic assessment is fundamentally based on the clinical interview and assessment with the patient. However, gathering collateral information from various sources (including collateral history from family members) is a routine and standard practice in medicine, including psychiatry. This is often essential in psychiatry, for addressing any safety concerns, alongside assisting with diagnostic clarification and determining a baseline.

My name is Jessica Poloz. I am a Counsellor and Group Facilitator in the Women and Violence program at the Eastern Ottawa Resource Centre. My contact information is below.

Ms. Moore first accessed our program in February 2018, when she began meeting with a Violence Against Women Counsellor for individual support. Ms. Moore has attended nine inperson counselling sessions to date. Topics that have been addressed in counselling have included types of abuse, safety planning, impacts of violence on children and navigating the family court process.

Our program provides short-term counselling and support to women whose lives have been impacted by violence. Our counselling services are goal-focused and seek to improve womens' emotional well-being and healing. Upon first meeting a client we assess the immediate needs of the person and work with them to identify goals of counselling, develop safety strategies and provide referrals linking clients to the services that would be appropriate for them. There is a psychoeducational piece to our counselling services where we provide women with information to assist them in identifying types of abuse, recognizing the warning signs of an abusive relationship, identifying barriers and breaking the cycle of violence.

It is not our practice to be used as witnesses for court purposes. We are not expert witnesses and we do not work with the whole family or provide family assessments. Therefore, for court purposes, we are limited to providing confirmation of types of services received, dates of services received and general topics that have been addressed in counselling.

Please see below for my responses to Ms. Moore's questions:

Ms. Moore has addressed coping strategies in counselling. She has indicated that safety planning, documenting her concerns, connecting with community supports, physical exercise and self-care strategies such as ensuring her physical health needs are met have been useful in helping her cope with her experiences.

8. Do you agree with the recommendation of the Office of the Children's Lawyer that sole custody should be awarded to Deirdre? Please explain.

We trust that the Office of the Children's Lawyer has done an assessment and will provide recommendations that they see fit the best interests of the children.



 Do you believe that John Kiska should be entitled to shared access to the children Sean and Cate given his lack of support for their overall care? Please explain.

We are not qualified, prepared or mandated to do family assessments and make recommendations with regards to custody and access issues.

10. Do you have any suggestions on how Deirdre can protect Sean and Cate from the impact of an emotionally abusive father?

When we are concerned about the emotional or physical safety of children we are required by law to report these concerns to the Children's Aid Society. We encourage women who are concerned about the impact of an abusive relationship on their children to connect with our Children's Counsellor for support.

Ms. Moore first accessed our program in February 2018, when she began meeting with a Violence Against Women Counsellor for individual support. Ms. Moore has attended five in-person counselling sessions to date. Topics that have been addressed in counselling have included types of abuse, safety planning and impacts of violence on children.

Ms. Moore has also discussed her hopes to provide education, outreach and support to other women who have experienced psychological and emotional abuse. She shared she has been proactive in reaching out to a variety of community organizations to identify the gaps in service in the Violence Against Women sector in the hopes of establishing her own not-for-profit organization or working for an existing one. One such gap that has been identified is a lack of awareness, understanding and resources for those who experience the more subtle forms of abuse, such as psychological and emotional abuse. Women affected by violence often have difficulty accessing services in a timely manner due to the high volume of clients requesting service and the subsequent lengthly waitlists. Ms. Moore herself has been on a waitlist for our Phase II support group for women for several months.

Longer-term and cost-effective community resources for women affected by all types violence are needed in the Ottawa area.

Ms. Moore has been attending counselling approximately once per month. Topics that have been addressed in counselling have included types of abuse, safety planning and impacts of violence on children.

Ms. Moore stated that throughout the course of her relationship with her ex-husband she experienced psychological and emotional abuse. She expressed that she continues to be concerned for her safety post-separation, as she said her ex-husband has stalked and harassed her and has hacked her electronic devices. We have discussed her safety concerns in-depth and have explored power and control tactics such as legal bullying and gaslighting.

Ms. Moore has also discussed her job search during her counselling sessions and has shared her progress with the goals she has set for herself. A referral to Agilec for employment support was provided.





Ottawa Victim Services (OVS) is a community service that provides emotional support, practical assistance, and referrals to community resources to victims of crime and tragic circumstances. Clients can access our services through community service agencies, the police or self-referrals.

Ms. Moore accessed our program in May of 2017. We have spoken with her a handful of times, most recent being the date this letter is dated for. Ms. Moore and I met to discuss the history of her relationship with her ex-husband, prior to their separation and the events that took place after. We also discussed her desire to work with victims of similar experiences at the hands of intimate partners. This pertains to less-overt forms of abuse such as psychological and emotional abuse.

Ms. Moore has expressed her interest in taking this matter to court to seek damages against her ex-husband regarding criminal harassment and criminal defamation. Ms. Moore showed me extensive efforts to document all ongoing interactions between herself and her ex-husband. It seems that this matter would be best handled in a court of law in order to be able to present her version of these events of the past few years and to discover the true facts of what has taken place.

Ms. Moore has been accessing the appropriate services and making every attempt to ensure her wellbeing. It is my hope that Ms. Moore is able to have this matter taken to court and to be able to present her evidence.

Thank you Dr. Kingston. I could meet next Thursday at any time between 10:00 and 3:00, depending on where you are situated.

Dr. Iris Jackson of Gilmour Psychological Services has helped me to survive this ordeal. I met her just over two years ago, have seen her often and as recently as Wednesday.

She has not diagnosed my husband as a narcissist, I have ... based on what he has done and continues to do to me. (I had been driven into psychosis 5 times between 2013 and 2015: among other things, he was gaslighting for sport ... which I only figured out when I found one of his "how-to" articles.)

My problem is this: the legal system does not understand mental health. Mental illness is mental illness, period. I need an expert to help me to establish some credibility in front of a judge. TOH's Dr. Kay has diagnosed me with Psychosis NOS and Dr. Jackson fine-tuned this to a diagnosis of Brief Psychotic Disorder with known stressors (i.e. my ex). I can forward to you her letter that she wrote for me if you like.

Dr. Jackson is willing to be with me at trial. She has already written a letter of support. But, having more than one would be helpful .... Plus (and this is a big plus) you have that background in psychiatry as well as that research which gives you a different type of credibility.

It has been a while since we have met. I have sent to you many e-mails in an effort to keep you "in the loop", but I am not sure if you received any of them as I never received any responses.

Currently, I am in the process of preparing for the upcoming trial where I intend to expose John Kiska for what he has done (and continues to do) to Sean and Cate and me for over six years.

In order to subpoena you to the trial, I must first retain a Expert Report and a C.V. from you and make it available to John's lawyer as well as the pre-trial judge. (Though you are not included in the attached endorsement, I do plan to subpeona you to testify and would like to provide Justice Engelking with your Expert Report in January along with all of the others.) Attached, you will find a list of 20 questions that I will be asking the four psychiatrists from The Ottawa Hospital who were primarily responsible for my diagnosis and care from 2013-present. - 2. Have you reviewed the list of 20 questions that Deirdre is posing to some of the psychiatrists who have cared for her in the past?
- 3. Do you feel that it is possible that Deirdre has developed a history of mental illness because she is the victim of a narcissist?
- 4. Can you offer any explanation for why John Kiska has consistently failed to mention the level of marital conflict that has existed in the marriage when he was speaking with Deirdre's physicians?
- 5. Can you offer any explanation for why John Kiska has consistently provided false information to Deirdre's treating psychiatrists?
- 6. Do you believe that John Kiska's behaviour towards Deirdre over the past six years reflects one of a loving, caring husband? Please explain.

Dr. Cardoso has been involved with the parents, who have attended 8 or 9 sessions. The couple started their sessions March 27, 2018. According to Dr. Cardoso, Ms. Moore self-referred. The parents had different goals: Ms. Moore wanted Dr. Cardoso to "covertly assess" Mr. Kiska as a psychopath, while Mr. Kiska's goal was to work on the couple's communication and co-parenting.

X

Dr. Cardoso is of the opinion that Ms. Moore is stuck in a "loop" and feels she is persecuted by Mr. Kiska. Dr. Cardoso feels this may be residual from Ms. Moore's "psychotic breaks". The relationship between Mr. Kiska and Ms. Moore is described as "toxic" by Dr. Cardoso. It marred with stone walling and defensiveness.

Ms. Moore appears to make progress within the sessions but Dr. Cardoso is of the opinion that she often regresses once she leaves. Ms. Moore presents as wanting to engage but there appears a capacity issue, as she reverts to "persecutory ideas" with a "delusional flavor".

With regards to "gaslighting", Dr. Cardoso stated that "there might be a kernel of truth but it is difficult to flush out". He feels that the mother is struggling with her" initial wound" and has difficulty seeing her role in the couple's conflict. Dr. Cardoso describes the couple's conflict as "legal warfare" and adds that this adds tension to the relationship and tension in to the homes. "This warfare is not useful". There are moments in the couple's relationship that are positive, but that then get impacted with the "barrage of emails and the accusation of being a psychopath" on the part of Ms. Moore towards Mr. Kiska.

A treatment team approach is the recommendation Dr. Cardoso feel may support Ms. Moore at this time. She is emotionally expressive in the sessions and engages in the process with slight flexibility. He acknowledges that this couple is highly intelligent and loves their children very much. "The family needs to come together and heal with the transition, and learn to navigate and communicate amicably". He adds that he is pleased to have the couple continue with the sessions.

If Tz. Cardoso had not reviewed any medical files or other documents provided by Moore when he provided these opinions to Katherine Bobula of the OCL.

Actually, the more I think about it, the more I think I screwed up the whole arrangement completely.

Dr. Kingston recommended CFIR for a family assessment. (I am not sure if you know this or not ... I have been diagnosed by TOH with Psychosis NOS which was fine-tuned by Dr. Jackson after two years of sessions and a series of tests to Brief Psychotic Disorder.) John has never been assessed and this is what I was looking for. CIPR reception was provided with the whole story and you were one of the psychologists recommended.

In speaking with Dr. Jackson, she says that you would not be allowed to do a family assessment now if you are actually providing couple therapy which, it seems, is actually what you are trying to do.

I think that perhaps, somewhere along the way, "you didn't get the memo", no offence.

John is, at a minimum, a pathological liar and, in my view, a psychopath.

How do I co-parent with a pathological liar who refuses to provide adequate financial support?

I've been assessed six ways from Sunday .. so you asking me about my childhood? It's weird. If you perceived a lot of dumb-struck looks from me last week, you perceived correctly.

Interested in understanding next steps.

Hi would to take the opportunity to clarify a couple of things before the next session as I was exhausted on Monday didn't express myself very clearly.

#1: Your question "When was the last time you felt something?" I interpreted as "When was the last time you EXPRESSED your feelings". Those are very different questions. Obviously I feel stuff all the time but don't have much opportunity to express it because of the massive smear campaign and know one wants to hear about my feelings.

#2: "When do you feel that your relationship started falling apart?" My position is, quite clearly, there obviously never was a real relationship. What kind of husband knowingly

has his wife hospitalized for a disease he knows she doesn't have + lies to psychiatrists to keep her in there for 2 months? So, I think your question is a tad irrelevant.

#3 When I told you that Kiska was studying bi-polar and narcissist books so he could feed the doctors symptoms, you said "it doesn't work that way." Dr. Cardoso, as I said, it absolutely DOES work that way and I have the medical files to prove it. How else does a psychotic person get diagnosed if not for total reliance on information from family members? Have you ever worked in a hospital environment?

So, I think we should re-visit your line of questioning again next week. As I said, I was absolutely exhausted on Monday and didn't pick up on the subtle nuances of your questions/comments.

In closing, I also find the fact that we can't discuss Kiska's lack of financial support weird. He makes \$175,000/year and pays me \$24,000 after 20 years?? Then he sits there and cries when he "feels sad"??

I know why I sought you out. I am losing confidence that YOU know why I sought you out.
